STRUCTURED FIGHTER PRACTICE

Our Canton has enjoyed a growth of new members and in concert with that growth new fighters as well. Since our group collectively decided to create a serious learning environment with an effort to "rehab" old loaner armor and get it into the hands of those new fighters. One of the first myths we had to dis-spell was that our fun sport was "expensive". The Our Canton had an armor workshop that used plastic covered by leather, fashioned chain-mail, shields and swords. This effort was done WITH the prospective member and a sort of nurturing relationship had begun.....

We then focused on training and technique... all the while we moved toward a more accessible location with plenty of visibility to our returning soldiers and students at the local college... yet still a well thought out training plan was developed.

Keeping in mind the following:

The object of practicing anything is to improve oneself.

No one practices at being mediocre or bad at anything.

Fighting in the SCA is no different than any other sport.

To get better, one has to practice.

Often-times fighters will attend Fighter Practice without a game plan or without a goal to attain or a specific "something" to learn. They walk out onto the field and select someone to "play" with. Frequently they pick the same person over and over. They exchange blows until both are tired and then they rest. There is little exchange of ideas. No actual instruction or learning. Bad habits are not corrected. Comments on various armor and weapons are not made. New ways of accomplishing objectives are not discussed. In a nutshell, they simply practice only that which they already knew (good or bad) without making progress.

Our first official fighter practice at that central location we used different focuses...

We devoted our training to: **Toe to Toe** technique.

This Drill is accomplished "Round Robin" style. The two fighters stand facing each other so that they are within perfect sword range. A mark is made on the ground (flour works well or a stick can be placed) where their forward foot toes are to be placed. The fighters are not allowed to move their forward foot at all or to move their back foot ahead of the foot on the mark. At the call "Lay On" the first fighter to connect with a good blow is the victor. The victor then in turn fights all other fighters with their toes on the mark until he loses and the victor of that bout becomes the "Robin". The purpose this Drill isto teach the fighter to hold his ground and not retreat.

Our next training we used the : **The Bear pit** technique.

This Drill is performed in a Bear Pit. A circle is drawn on the ground (flour works best for this) and both fighters MUST stay within the circle. Other fighters or observers call out a fighter's name if he

gets within one foot of the edge. The size of the Bear Pit is dependent upon the skill of the fighters in fighting in close quarters. As their experience grows, the size of the Bear Pit should shrink. The object is not to push a fighter out of the pit or to have him to accidentally step out of it, but to teach fighters how to fight in a confined area, remain on the offense and not "run backwards"..

The following practice we devoted our training to: **Group Critique** technique.

This Drill requires the fighter to engage each person at fighter practice for one or two bouts. After he has engaged them all, the fighter's opponents are to critique him one at a time in the group that fought him. They are to give both positive and negative feedback. All negative feedback **MUST** be done with a suggestion of what could be done better or different. This Drill teaches the fighters to verbalize their thoughts and provides for positive reinforcement

Finally, we devoted the next practice to: **The Off Hand** technique.

Most people are either right or left handed. Even those who are ambidextrous tend to have a dominate hand. For this Drill the fighter is to fight with his off-hand. His opponent is to fight with his dominate hand. This drill allows a fighter to develop his off-hand skills while enabling him to retain use of his shield.

Lastly we incorporated a technique called: **Back Peddling**

At one time or another, a fighter will engage someone who remains on the offensive due to skill or sheer size. This Drill gives a fighter practice on fighting while "advancing backwards". The fighter can only move his feet backwards, sideways or completely turn around. He cannot take any steps forward. His opponent can move in any direction. This Drill teaches a fighter to have confidence in his ability even if it appears that he is on the defensive or has been overpowered.

Having structured practices prepare our fighters, new and old, a challenge and prepares them for individual advancement as well.
